I invite your kind attention to the enclosed list of Gram Panchayats identified under **Saansad Adarsh Gram Yojana (SAGY)** in 2019-20 from **Uttar Pradesh**.

Department of Rural Development held an orientation programme on SAGY for the newly elected Hon'ble Members of Parliament (MPs) on 3 December 2019 at the Parliamentary Research and Training Institute for Democracies (Erstwhile BPST), New Delhi.

It was resolved in the meeting of National Level Committee on SAGY chaired by Secretary, RD on 9 December 2019 at New Delhi that Village Development Plans (VDP) in the SAGY Gram Panchayats should be prepared in synergy with the Gram Panchayat Development Plans (GPDP) utilising the Mission Antyodaya survey results. In this regard, you are requested to issue directions to leverage the services of the Mission Antyodaya survey facilitators in the preparation of VDPs.

May I also take the opportunity to request your kind intervention for ensuring the following in conformity with the outcome of the above mentioned orientation programme and the resolve taken by National Level Committee on SAGY :

- Direction may be issued for the formulation of Village Development Plans (VDP) in SAGY Gram Panchayats based on Mission Antyodaya gap analysis reports.
- The VDPs of SAGY Gram Panchayats may be taken into consideration for GPDP preparation since VDP is planned to be completed in a three year period while GPDP is an annual exercise.
- Direction may be issued to organize an orientation programme on SAGY (2019-24) for the Hon'ble MPs in the State. Charge Officers may be invited for the said training to enable better coordination between Hon'ble MPs and concerned Charge Officers.
- Directions may be issued to the District Collectors to carry out a monthly review on SAGY with representatives of the participating line departments. (The Hon'ble MP concerned may be invited to chair the review meetings).
- State Nodal Officer, SAGY and the District Collectors may pursue with the Hon'ble MPs to identify the Gram Panchayats under SAGY (2019-24).
